4. First-aid measures

Eye: Immediately flush eyes with plenty of water for at least 15 minutes. Get immediate medical attention.

Skin: Wash immediately with plenty of soap and water. Call a physician immediately. Take off all contaminated clothing immediately.

Ingestion: Call a physician immediately. Clean mouth with water. Drink plenty of water. Do not induce vomiting without medical advice. Never give anything by mouth to an unconscious person.

Inhalation: Move to fresh air. Call a physician immediately. If breathing is irregular or stopped, administer artificial respiration.

5. Fire-fighting measures

Suitable extinguishing media: Water fog, carbon dioxide, foam, dry chemical powder.

Other considerations: Do not use water jet as an extinguisher, as this will spread the fire.

Fire fighting procedures: In case of fire and/or explosion, do not breathe fumes. Move containers from fire area if can do so without risk. For massive fire in cargo area, use unmanned hose holder or monitor nozzles, if possible. If not, withdraw and let fire burn out.

Fire fighting equipment: In the event of fire, wear self-contained breathing apparatus.

Hazardous decomposition products: Vapors may form explosive mixtures with air. Vapors may travel considerable distance to a source of ignition and flash back. During fire, gases hazardous to health may be formed.

6. Accidental release measures

Small spill: Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Large spill: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Prevent product from entering drains.

Environmental precautions

Water spill: 5% of the mixture consists of component(s) of unknown long-term hazards to the aquatic environment.

General procedures: Contain spillage and then collect with non-combustible absorbent material, (e.g. sand, earth, diatomaceous earth, vermiculite) and place in container for disposal according to local / national regulations.

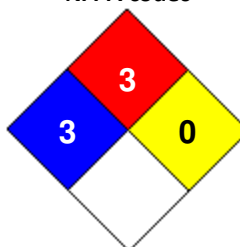
